

There are **1,486 federal inmates** and **638 B confirmed positive test results for COVID-19 nationwide**. Currently, **10,380** inmates and **893** staff been **116** federal inmate deaths and **1** BOP staff member death attributed to COVID-19 disease. occurred while on home confinement.

Due to the rapidly evolving nature of this public health crisis, the BOP will update the open COVID-19 confirmed posi and the number of COVID-19 related deaths daily at 3:00 p.m. The positive test numbers are based on the most recei **results** involving **open cases** from across the agency as reported by the BOP's Office of Occupational Health and Saf BOP field sites may report additional updates throughout the day. began immediately reviewing all inmates who have COVID-19 risk factors, as described by the which inmates are suitable for home confinement. Since the release of the [Attorney General's Bureau of Prisons](#) on March 26, 2020 instructing us to prioritize home confinement as an appropriate COVID-19 pandemic, the BOP has placed **7,578** inmates on home confinement.
