Every institution is like a small city and to cope with major emergencies or other significant interruptions of normal operations, they each have continuity of operations (COOP) plans that provide guidance to staff.

BOP's COVID-19 Response

In February 2020, the BOP's Public Health Service (PHS) staff were placed in operational dress uniforms to be ready to respond to COVID-19 incidents by the Assistant Secretary for Health.



COVID-19 Cases

08/04/2020 - The BOP has **128,542** federal inmates in BOP-managed institutions and **13,663** in contract facilities. The BOP staff complement is approximately **36,000**. There are **2,017 federal inmates** and **542 BOP staff** with confirmed positive test results for COVID-19 nationwide. Currently, **8,663** inmates and **720** staff have been tested. There have been **108** federal inmate deaths and **1** BOP staff member death attributed to COVID-19 disease. **1** inmate death occurred while on home confinement. Given the surge in positive cases at select sites and in response to the Attorney General Barr's began immediately reviewing all inmates who have COVID-19 risk factors, as described by the which inmates are suitable for home confinement. Since the release of the [Attorney General's](#) Bureau of Prisons on March 26, 2020 instructing us to prioritize home confinement as an appr COVID-19 pandemic, the BOP has placed **7,276** inmates on home confinement.
