

Sheriff and Police Departments

The following defines the qualification and the enhanced access rights for the BMV Record search applications that Sheriff and Police Departments will receive.

Qualification Requirements

All of the following qualifying requirements must be met:

Sherriff

1. Confirmation email from the Sheriff's Association of Indiana verifying the Sheriff's department and personal.

Police

1. Police Chief must be listed on the IN.gov Account agreement under 'Name of elected official or head authority of entity'.
2. Police Chief must fill out and sign the BMV Enhanced Access Agreement for Government Entities.
3. Police Chief must be listed on the city's police department website.
