Every institution is like a small city and to cope with major emergencies or other significant interruptions of normal operations, they each have continuity of operations (COOP) plans that provide guidance to staff.

Currently, **656** inmates and **279** staff have been **48** federal inmate deaths and **0** BOP staff member deaths attributed to COVID-19 disease.

COVID-19 Home Confinement Informatio

Given the surge in positive cases at select sites and in response to the Attorney General B. BOP began immediately reviewing all inmates who have COVID-19 risk factors, as describ determine which inmates are suitable for home confinement. Since the release of the [Attc original memo](#) to the Bureau of Prisons on March 26, 2020 instructing us to prioritize hon appropriate response to the COVID-19 pandemic, the BOP has placed an additional **2,428** confinement; an increase of **85.9** percent.
