More children were taken into protective custody and assigned to CASA in 2012 than any prior year. Meeting the needs of this wave of children in crisis required more CASA advocates to be trained. Volunteers answered the call and CASA of Williamson County continues to assign all children entering the local courts due to abuse and/or neglect to a trained CASA advocate to be their voice in court.

## **Story in the Stats**

- \* The Illinois Department of Child and Family Services receives and investigates a report of suspected child abuse or neglect every five minutes, and a report of child sexual abuse every two hours
- \*In Williamson County, there were 1066 reports of child abuse and/or neglect made to the Illinois Child Abuse Hotline in 2012
- \*Other than a parent, the paramour (live-in boyfriend/girlfriend) is the most likely indicated perpetrator of child

abuse and/or neglect

- \*In 2012, Williamson County had the 5th highest number of child abuse and/or neglect reports in Illinois based on population
- \*Child abuse and neglect reports increasted 5% statewide in Illinois in 2012
- \*CASA of Williamson County is assigning three times more children in crisis to trained CASA advocates every year than ten years ago

## DCFS Reports . . .

Child deaths caused by neglect or abuse skyrocked in 2012, according to end-of-year analysis by the Illinois Department of Children and Family Services. Neglect or abuse was indicated in the deaths of 90 children in 2012, according to investigations alrady completed by DCFS, with more than 60 recently reported deats still under investigation. Indicated child deaths occurred in equal numbers in Chicago, the suburbs, and downstate Illinois; 69 percent of victims never saw their first birthday.

Six new CASA advocates were trained on Tuesday and Thursday nights in October and were sworn-in as officers of the court in September. All are ready to take their first case in serving a locally abused or neglected child in need. Throughout their training, they were educated on several important topics to become effective CASAs. Topics

included: domestic violence, poverty, mental illness, substance abuse, the needs of children and families, report writing, juvenile law and more. "CASAs have many responsibilities, but the most important is to help ensure the child is in an appropriate and safe foster home from the start of the case," states CASA Director Cheri Fitts.
