Prohibited Personnel Practice

I want to report an unlawful personnel action or decision, such as retaliation, discrimination, or improper candidate selection.

Disclosure of Wrongdoing

I want to report wrongdoing of the type listed below that is NOT related to a personnel action or decision:

- Gross mismanagement
- Substantial and specific danger to public health or safety
- Gross waste of funds
- Violation of a law, rule, or regulation
- Abuse of authority

Note: If you believe a personnel action or decision is, itself, the abuse of authority, gross mismanagement, or any of the wrongdoing listed
