**AN ORDINANCE AMENDING CHAPTER 90 OF THE MUNICIPAL CODE  
OF THE CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS**

**BE IT ORDAINED** by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, by and through its home rule powers, as follows:

**Section 1.** That Section 90-317 (Handicapped parking) of Article V [Stopping, Standing and Parking] of Chapter 90 [Traffic and Vehicles] of the Municipal Code of Calumet City, Illinois, is hereby amended by adding the following language to subsection G (Signed areas) to read, as follows:

502 Marquette Avenue

1767 Memorial Drive

34 Webb Street

**Section 2.** The Commissioner of Streets and Alleys is hereby authorized and directed to install the proper signs in accordance with the terms and conditions of this Ordinance.

**Section 3.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 4.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 5.** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.



**ORDINANCE NO. 16- 21**

**AN ORDINANCE ADOPTING THE  
PREVAILING WAGE STANDARDS IN THE  
CITY OF CALUMET CITY, COOK COUNTY, ILLINOIS**

**WHEREAS**, the State of Illinois (the "*State*") has enacted the "Prevailing Wage Act," 820 ILCS 130/1 *et seq.* (the "*Act*") which is an act regulating wages of laborers, mechanics and other workers employed in any public works by the State, county, city or any public body or any political subdivision or by anyone under contract for public works; and

**WHEREAS**, it is the policy of the State that a wage of no less than the general prevailing hourly rate as paid for work of a similar character in the locality in which the work is performed, shall be paid to all laborers, mechanics and other workers employed by or on behalf of any and all public bodies engaged in public works; and

**WHEREAS**, the Act requires that the City of Calumet City investigate and ascertain the prevailing rate of wages as defined in the Act for laborers, mechanics and other workers in the locality of the City of Calumet City employed in performing construction of public works, for the City of Calumet City; and

**WHEREAS**, the City of Calumet City has ascertained and examined the prevailing wage classifications and rates determined by the Department of Labor for Cook County for June 2015, which is the last available date wage rates were published by the Department of Labor.

**NOW, THEREFORE**, be it ordained by the Mayor and City Council of the City of Calumet City, Cook County, Illinois, as follows:

**SECTION 1:** That the above recitals and legislative findings are incorporated herein and made a part hereof.

**SECTION 2:** To the extent and as required by the Act, the general prevailing rates of wages in this locality for laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of the City of Calumet City is hereby ascertained to be the

same as the prevailing rates of wages for construction work in the Cook County area, as determined by the Department of Labor of the State of Illinois as of last available date wage rates were published by the Department of Labor..

**SECTION 3:** As required by the Act, any and all revisions of the prevailing rates of wages by the Department of Labor of the State of Illinois shall supersede the Department's last publication of prevailing rates for construction work undertaken by the City of Calumet City. The definition of any terms appearing in the Ordinance which are also used in the Act shall be the same as in the Act.

**SECTION 4:** Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction undertaken by the City of Calumet City to the extent required by the Act.

**SECTION 7:** The City Clerk shall promptly file a certified copy of this Ordinance with the Honorable Jesse White, Secretary of State of Illinois, Index Department 111 East Monroe Street, Springfield, IL 62756 and with the Illinois Department of Labor, Prevailing Wage Division, One West Old State Capitol Plaza, Room 300, Springfield, IL 62701.







City Attorney - statement

City Attorney Odelson: "The trend in the last number of years is to ask its citizens if they would like to pass a term limits. Passage of a question of this nature allows the citizens and the voters to change their form of government and limit the number of terms an elected official can serve.

For instance, right next door in Lansing, they have had term limits for a good number of years. Other municipalities, as recently as last election, Country Club Hills and Tinley Park have passed a term limits.

This would mean, someone like the current Mayor, if this passed, the Mayor would be only able to run one more time and then she would be term limit out.

This is a ballot initiative that the people get to vote on it. If the people vote it down, it doesn't go into place. If they vote for it, it goes into place effective for the April 4, 2017 election and thereafter.

It doesn't impact any other office, such as the City Clerk, City Treasurer or Aldermen. Only the office of Mayor."

Alderman Jones: "In the language, correct."

City Attorney Odelson: "The years that aldermen serve are computed in the term limits and language.

For instance, if an aldermen have served 4 or more consecutive terms, they would not be able to run for a 5<sup>th</sup> elected term as Mayor. They could run for aldermen."

Alderman Jones: "Could you explain why there is no alternative in this city agenda. Or why the City Clerk or all city wide offices are not included in this ordinance before us tonight."

City Attorney Odelson: "Calumet City, which is a strong Mayor, City Council form of government without a Manager or an Administrator. The power in the office of Mayor is more so then any other communities. They have a manager form of government or city administrator form of government or a strong council form of government.

The aldermen and the mayor hold the power to hire, fire, set salaries. All powers given by the state statute. The clerk and the city treasurer function according to the duties given them by the state statutes and by the ordinances.

They have no legislative or executive functions, therefore their powers are limited to what is given them by the General Assembly or the ordinances themselves.

They function as decision makers within their own department and don't have any authority to budget pass ordinances, veto ordinances. The real powers behind elected officials."



Alderman Jones: "Where I support submitting question to the voters. This ordinance is strictly reactionary to whatever is happening in our community.

I will implore my colleagues not to give the Mayor the opportunity to have a free pass at another term in office. That is what this ordinance, if you vote yes will do. I will be voting no on this ordinance. That is all."

Alderman Manousopoulos; "I believe when Lansing, I think it was a couple elections ago. They put a referendum to lift term limits and I believe it was voted down. If I am not mistaken."

City Attorney Odelson: "That is correct. I don't know of another municipality that has lifted term limits once they have it. The trend now is to install term limits. This will not limit the citizens in Calumet City from running for Mayor, if they haven't served 4 full terms."


