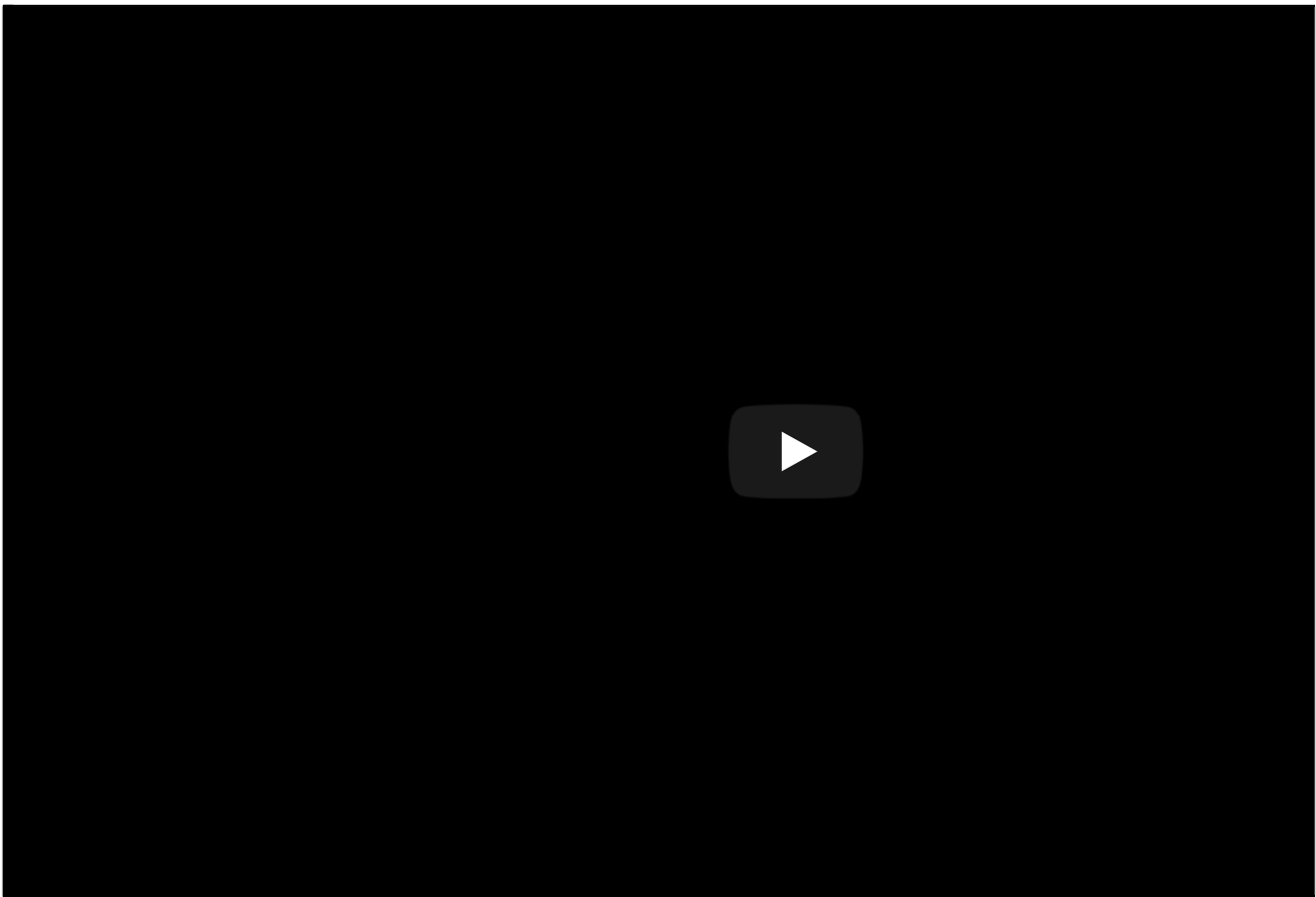

The court is aware that given the on-going COVID-19 public health emergency, parties in civil litigation have and will continue to take depositions by remote means.
