There are **1904 federal inmates** and **175 B** confirmed positive test results for COVID-19 nationwide. Currently, **3631** inmates and **448** staff here are **71** federal inmate deaths and **0** BOP staff member deaths attributed to COVID-19 disease.



COVID-19 Home Confinement Informatio

Given the surge in positive cases at select sites and in response to the Attorney General Barbon BoP began immediately reviewing all inmates who have COVID-19 risk factors, as described determine which inmates are suitable for home confinement. Since the release of the Attoriginal memo to the Bureau of Prisons on March 26, 2020 instructing us to prioritize hom appropriate response to the COVID-19 pandemic, the BOP has placed an additional **3,610** confinement; an increase of **127** percent.
