

Ways To Vote

Visitors can find more information on each topic by selecting the corresponding tab to the right.

There are three ways to cast a ballot in suburban Cook County for the 2018 Gubernatorial Elections. Eligible voters can participate in Early Voting, Vote By Mail or on Election Day at their assigned polling place.

Early Voting (/agency/early-voting)

Traditional Early Voting will take place March 5-19 for the March 20, 2018 Gubernatorial Primary Election.

Voters can cast a ballot at any one of the Clerk's 52 Early Voting sites. Click the "Early Voting (/service/early-voting-locations)" tab to the right for hours and locations.

As a reminder, voters who participate in Early Voting must vote in person.

Vote By Mail (/agency/vote-mail)

Mail Ballot applications for the March 20, 2018 Gubernatorial Primary Election will be accepted starting December 20, 2017.

Any registered suburban Cook County voter with a driver's license, state ID or social security number on file may request a mail ballot using an online or paper application.

Ballots must be postmarked by Election Day (March 20) in order to be counted.

Election Day Voting (/service/polling-locations)

Registered suburban Cook County voters can only vote in their home precinct on Election Day.

Residents who are not registered to vote may register and cast a ballot on Election Day thanks to same-day registration and voting. Those who wish to register on Election Day must present two qualifying forms of ID.


Registered and unregistered Cook County residents can find their assigned polling place with the Your Voter Information tool (/service/your-voter-information).
