## GENERAL PUBLIC ORDER GRANTING THE STATE OF WISCONSIN DEPARTMENT OF JUSTICE'S *EX PARTE* MOTION FOR EXTENSION OF TIME DUE TO EXTRAORDINARY CIRCUMSTANCES

The Wisconsin Department of Justice has asked the court for an order staying deadlines in open civil cases brought by plaintiffs who are or were previously incarcerated by the Wisconsin Department of Corrections ("Wisconsin DOC Inmates") and relate to prison litigation in which the DOJ currently represents at least one of the defendants.

For the reasons in the State of Wisconsin's *Ex Parte* Motion for Extension of Time Due to Extraordinary Circumstances, the court **GRANTS** the motion and orders as follows:

- 1. In civil cases brought in the federal court for the Eastern District of Wisconsin by Wisconsin DOC Inmates, all deadlines are **STAYED** to the extent that those deadlines fall within the time period that the Governor's Safer at Home order is in effect; such deadlines are **EXTENDED** until forty-five (45) days after Governor Evers' Safer at Home Order is lifted or expires.
- 2. In civil cases brought in the federal court for the Eastern District of Wisconsin by Wisconsin DOC Inmates, all deadlines are **STAYED** to the extent

that those deadlines are within fifteen (15) days after the date the Governor's

Safer at Home order is lifted or expires; such deadlines are **EXTENDED** until

thirty (30) days after Governor Evers' Safer at Home Order is lifted or expired.

3. The court **ORDERS** that if, between March 13, 2020 and the date

of this order, parties have sought and received stays or extensions in specific

cases, this order does not apply. Parties who have sought and received stays or

extensions in open civil cases brought by Wisconsin DOC Inmates and relate to

prison litigation in which the DOJ currently represents at least one of the

defendants between March 13, 2020 and the date of this order must abide by

the ruling of the judge in the particular case.

To facilitate informing inmate parties of this order without filing the

motion and entering this order in each of the pending cases brought by

incarcerated individuals, the court **ORDERS** that the Wisconsin Department of

Justice will mail a copy of this order and the accompanying motion to all

Wisconsin DOC Inmates who have an open case in which the DOJ currently

represents at least one of the defendants. The court **ORDERS** that the mailing

must take place within three business days of the entry of this order.
