We offer 30 innovative programs at more than 100 locations throughout Chicago, the adjacent suburbs, and nine surrounding counties. Services include assertive outreach, case management, housing, employment, education, psychiatry, primary care, substance use treatment, and research. **Last year, Thresholds served more than 16,000 adults and youth, with 75% of services delivered out in the community, representing more than 500,000 hours of care.**

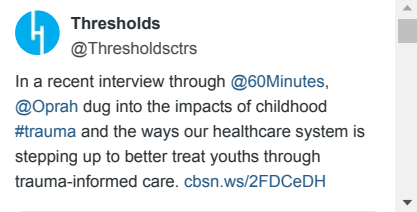
